## DR. HAROLD KERZNER, Programme Director

Dr. Harold Kerzner, MS, Ph.D. (Engineering), MBA, is the President of Project Management Associates Inc. - a renowned consulting company based in Cleveland, USA. His expertise is in the areas of Project Management and Strategic Planning. He obtained his industrial experience at Thiokol Corporation where he held both program management and project engineering responsibilities on a variety of NASA, Air Force, Navy and IR & D programs.

Dr. Kerzner has published more than sixty engineering and business papers and has 13 text books to his credit. His book entitled: *Project Management - A Systems Approach to Planning, Scheduling and Controlling* is a standard reading in many leading universities in USA.

Dr. Kerzner has been a consultant to over 100 leading US companies such as NASA, Dow Chemical, Standard Oil of Ohio, DuPont, The Goodyear, General Electric, Ford, Firestone, Westinghouse, Kodak, TRW, Philip Morris, Allen-Bradley, LTV Steel, Kellogs, Corning Glass, Minnesota Power & Light, Ohio Bell, 3M, Department of Transportation, Internal Revenue Service, The Department of Defense, Blue Cross etc.

### A.C. JAIN, Director incharge

Mr. Jain, a graduate in Engineering from Indian Institute of Science, obtained his Masters of Engineering from Canada. He worked with the multinational companies like Litton Systems and Control Data.

On his return to India in 1973, Mr. Jain looked after commercial and process control applications at Bokaro Steel Limited. In 1975, he joined the Corporate Office of BHEL as Chief of EDP coordination. In view of his concrete and effective contribution in Computers, Systems and Project Management in BHEL, he had the distinction of being awarded 3 promotions in 4 years. He was one of the key persons to evolve Integrated Project Management System for BHEL facilitating the spread of scientific project management techniques in Indian environment.

In 1982, a Heavy Engineering Computer Group comprising of 22 public sector undertakings was formed and Mr. Jain was elected as its first Chairman. He is closely involved in Consultancy assignments for various leading public and private sectors enterprises. He had the honour of representing India at the UNESCO conference in Indonesia and was invited to address a prestigious symposium for senior European executives in France.

Mr. Jain is the President, Noida Management Association and Chairman of the Information Management Committee, DMA. He is a fellow of IETE and was recently awarded the Fellowship of the CSI by the Vice President of India.
